### **BIOSKETCH:**

Joel Michael Reynolds (PhD, MA) is Provost’s Distinguished Associate Professor of Philosophy and Disability Studies, Senior Research Scholar in the Kennedy Institute of Ethics, and Faculty in the Disability Studies Program and the Medical Humanities Initiative at Georgetown University. They are also jointly appointed as Faculty in the Pellegrino Center for Clinical Bioethics and the Department of Family Medicine at Georgetown University School of Medicine and Medical Center. Reynolds is author or co-author of seven books and over seventy scholarly publications spanning philosophy, biomedical ethics, and public health. They are the founder of *The Journal of Philosophy of Disability*, the first journal devoted to the field, and co-founder of the book series *Oxford Studies in Disability, Ethics, and Society*, the first book series devoted to disability in Oxford University Press’ history. An internationally recognized expert on disability, their work has been translated into multiple languages, and they have given over 150 keynote addresses and endowed lectures, conference talks, and grand rounds at universities and schools of medicine across the globe. In recognition of the impact of their scholarship, they were named an Honorary Fellow of the McLaughlin College of Public Policy at York University in 2022, elected as a Fellow of the Hastings Center for Bioethics in 2023, selected as a Faculty Scholar of the Greenwall Foundation (Class of 2025), and won the Provost’s Distinguished Associate Professor award in 2026. Dr. Reynolds’ work has appeared or been cited in outlets including *TIME*, *The Atlantic*, *The New Yorker*, *The Wall Street Journal*, *Forbes*, *Truthout*, and a *Tedx* talk.
